

New Management Structure, Executive Appointments and Resignations

Tokyo, January 30, 2020 – Fujitsu Limited has made the following changes to its management structure as of April 1, 2020 and the subsequent decision on the appointment of directors and executive officers.

1. Changes to the Management Structure

To accelerate the transformation from an IT Company to a DX company, Fujitsu will restructure its organization at the level of departments and business groups.

- For Fujitsu to accelerate its fundamental reexamination of its systems and processes while transforming into a DX company, Global Corporate Functions will be terminated and all corporate functions will be under the direct control of the CEO.
- For sales and system engineers to set common goals and work together to globally promote DX for customers, Japan Sales and Technology Solution Business will be restructured from the perspective of services and a new organization, Global Solutions, will be created.
- Public Sector & Regional Sales, Social Infrastructure, and Defense Systems that specialize in the Japanese market will be organized as the Japan Region including Fujitsu Marketing Limited, with the aim of further expanding their businesses in the Japanese market.
- The five regions outside Japan will implement unified governance as International Regions.
- To enable flexible decision-making in managing the platform business, Service Platform Business Group will be changed to System Platform Business under the direct control of the CEO.

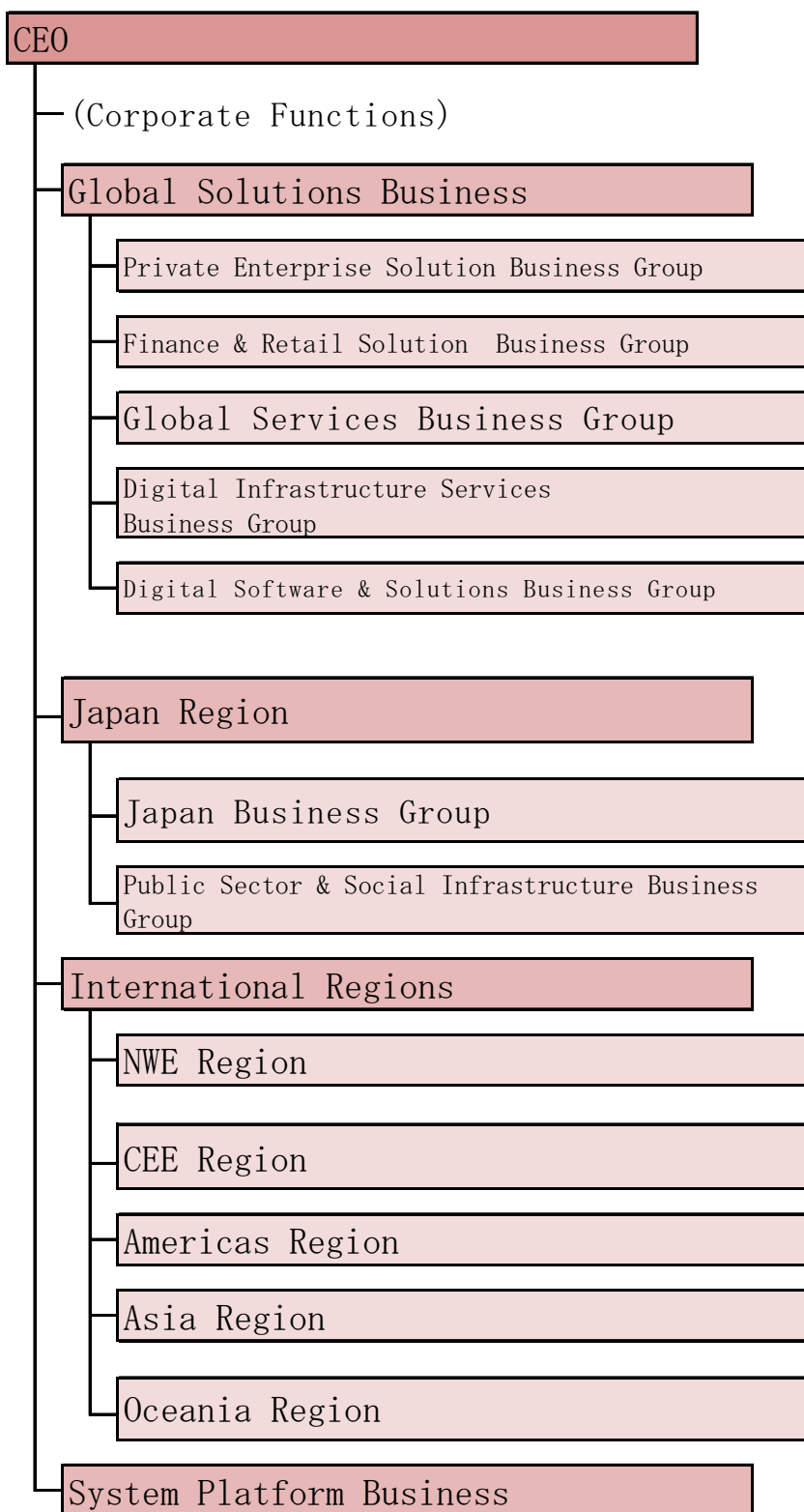
