

New management structure, Executive Officers appointments and resignations

Tokyo, January 31, 2023 - Fujitsu Limited today announced the following changes to its management structure and accompanying decisions on the appointment and resignation of executive officers.

1. Changes to the management structure

The new management structure to implement the new medium-term management plan from April 2023 will be as follows, aiming at sustainable growth and improvement of corporate value of Fujitsu itself and creation of new value through the pursuit of Fujitsu's corporate Purpose.

Summary of changes as follows:

- A new "CRO (Chief Revenue Officer)" will formulate and execute strategies to maximize profits from a global perspective across the company's regional businesses.
- A new "CPO (Chief Portfolio Officer)" position will be established to formulate and implement a portfolio strategy for optimal allocation and management of resources, selecting and concentrating on service and products from a group-wide perspective.
- The existing Global Solutions Business Group will be reorganized into two separate business groups: the Global Technology Solutions Business Group and Global Business Solutions Business Group. This step will serve to accelerate the expansion of the business, which will center on Fujitsu Uvance, an area of future growth.

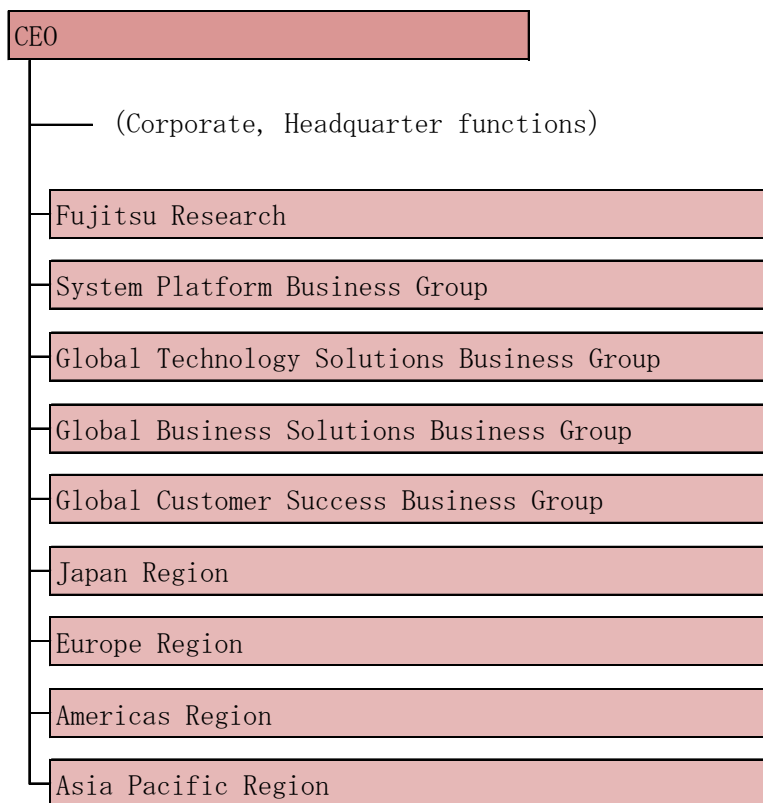
